- Open RFPs in Iowa Grants include:
 - Thrive Iowa - Due Dec 1
 - Expanding Iowa Early Childhood Continuum of Care - Due Jan 28
 - MOMS (More Options for Maternal Support) - Due Oct 20

- DECAT/CPPC Mini Grants will be available this year of \$500-950 for Wayne, Decatur and Clarke to support local events or programs that benefit children and families 0-18 that meets one of the four strategies of CPPC and that serves an identified target population.
- State ECI Workgroup Meeting scheduled for Oct 17 and State ECI Board Meeting scheduled for Nov 7.
- SCICAP recruiting for a FaDSS Family Development Specialist
- Board Member application for board to review.

New Business

- FY2023 Audit Summary was reviewed by the board. No Findings for Kids First Communities.
- An ECI district update was given to the KFC board. Current maps were reviewed of the new districts and ECI areas. District 5 is not planning on submitting a letter of intent to merge into the district. Discussion on options for the KFC board if district 4 forms, which currently shares the director, including subcontracting with current director, hiring, or possibly merging with another ECI area. All on hold at this time, board continues to wait for state ECI updates for FY2027.
- Program/Contract Monitoring schedule has been uploaded into Iowa Grants as required. Q2 Site Visits include Mormon Trail, Seymour and Clarke/Decatur PAT program.
