Crystal Hansen with The Village updated the board on the upcoming 3-Year-old Preschool year. All families who are of need of tuition assistance will first complete a CCA application and then if they are denied, they will then apply for a KFC Preschool Scholarship. Currently have 21 enrolled with 5 pending, where 24 can be accepted for max numbers.

Jen Mitchell from SCICAP Headstart updated the board that their 3 & 4 year old Headstart preschool program has room for 40 students and currently have 28 children enrolled.

Discussion on preschool options in Osceola include preschool options not only at The Village and SCICAP Headstart, but also Preschools are available at the School and Over the Rainbow.
